- f. Class X Mark sheet (Only Digilocker document will be accepted for CBSE students) For Non CBSE students photocopy of Mark sheet. (Self attested)
- g. Birth Certificate in the name of Child.
- h. Caste Certificate in the name of Child ( Self attested ) if applicable .
- i. Blood group of Child
- j. Aadhar Card of Child
- k. Photograph 01 Copy coloured photograph (to be pasted on Registration form.)
- I. Certificate in Sports/ Adventure /Scouting/ NCC etc.: highest achievement of the Child ( if any )

All the photocopies have to be self-attested except – Service certificate and Salary certificate. Registration form and Option form may please be downloaded from the website **khanapara.kvs.ac.in** and filled up for registration.

### Some general informations:

# Concept of category of parent Category I to V as defined in KVS Admission guidelines:

**Category 1**: Children of transferable and non-transferable Central government employees and children of ex- servicemen. This will also include children of Foreign National officials, who come on deputation or transfer to India on invitation by Govt. of India.

**Category II**: Children of transferable and non-transferable employees of Autonomous Bodies / Public Sector Undertaking/Institute of Higher Learning of the Government of India.

**Category III**: Children of transferable and non-transferable State Government employees.

**Category IV**: Children of transferable and non-transferable employees of Autonomous Bodies/ Public Sector Undertakings/Institute of Higher Learning of the State Governments.

**Category V**: Children from any other category including the children of Foreign Nationals who are located in India due to their work or for any personal reasons. The children of Foreign Nationals would be considered only in case there are no Children of Indian Nationals waitlisted for admission.
