Sir/Madam,

The Kendriya Vidyalaya Sangathan, a centrally funded Autonomous Body, is a society registered under Societies Registration Act 1860. The Sangathan administers the scheme of Kendriya Vidyalayas set up for imparting education to the children of transferable Central Government employees.

Sealed competitive quotations from Registered firms are invited by the undersigned on behalf of the Kendriya Vidyalaya Army cantt, Pangode as per the schedule attached.

No	Brief Description of work
1(a)	Painting with one coat of cement based paint on old surface after scrapping and cleaning the surface completely. (per sq. Metre ) (Approximate area.. 7495 sq.m)
1(b)	Painting with two coats of weather coat apex on all borders on old surface after scrapping and cleaning the surface completely.(per sq. Metre ) (Approximate area.. 600 sq.m)
2(a)	Preparing the surface after cleaning and applying one coat of washable distemper in the inner sides and ceilings.(per sq.m) (Approximate area...8621sq.m)
2(b)	Painting with two coat of synthetic enamel paint on all wooden(door and window) and metal surfaces (window grill) after rubbing and cleaning the surface completely. (per sq.m) (Approximate area...500 sq.m)

- a) The contract shall be for the Work of the mentioned items for Kendriya Vidyalaya, Pangode, Trivandrum . The bidder shall quote the rates for items of work in the attached format.
- b) All taxes, duties and other levies payable by the bidder, shall be included in the total price. They shall be quoted separately.
- c) The rates quoted by the bidder shall be fixed for the whole duration of the contract.
- d) Each bidder shall submit only one quotation. Telex or Facsimile quotations are not acceptable.
- e) The bid should be submitted along with EMD for Rs. 5000/- by Bank Draft in favour of VVN Account of Kendriya Vidyalaya Pangode.
- f) The firm should enclose supporting documents regarding registration of TIN /VAT/ST/IT PAN (in the name of the firm.)/IT return of the firm for the last three years.

### **3. Validity of Quotations**

The quotation shall remain valid for a period of one year after the deadline date for the submission of quotations.

### **4. Evaluation of Quotations**

The purchaser will evaluate and compare the quotations determined to be substantially responsive, ie, which are

- a) Properly signed with stamp & seal of the firm.
- b) Conforming to the terms and conditions and specifications.
- c) The bidder who has quoted for partial work of any one or more items(s) shall be considered as non-responsive

### **5. Award of Contract**

The purchaser shall award the contract to the bidder whose quotation has been determined to be substantially responsive and whose total cost for all the work items put together is the lowest.

- a) The bidder whose bid is accepted shall be notified about the award of contract, by the Office, prior to the expiration of the quotation validity period.
- b) Normal commercial warranty/ guarantee shall be applicable to the service provided.
- c) Payment shall be made within 15 days after the job is completed and accepted by the Vidyalaya.
- d) Notwithstanding the above the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

6.

- a) The awardee of the contract shall begin the work only after obtaining the APPROVAL OF THE Work Committee.
- b) No material/ services like electricity, water, brush, cleaning material etc shall be provided by the purchaser.
- c) All the display boards, pictures, etc presently fixed on the walls shall be removed before the painting and refixed after the work by the awardee of the contract.
- d) Complete and perfect cleaning of the floor and furniture in the rooms shall be done by the awardee after the painting.
- e) The awardee of the contract shall be liable to compensate the damages caused to the building or the materials in the building, if any, during the work.
- f) The awardee of the contract shall be liable to pay compensation/penalty if the said work is not completed within the stipulated time.
- g) No painting to be started before the cleaning of that particular block is completed.
- h) The second coating to be started only after finishing the first coating. It is the responsibility of the bidder to see that the exact color is shining after the second coating ie the old color to be totally hidden. No shade of the old color to be seen.
- i) **The proposed work to be executed during .....**
- j) The successful bidder has to deposit performance security of the total amount of Rs. 10% in favour of Principal Kendriya Vidyalaya Pangode in the form of Demand Draft. At the time of payment, TDS will be deducted as per rules.

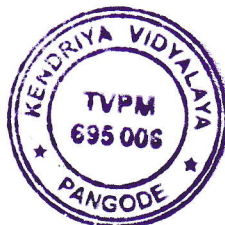
